CAT 1 \$2.00 per child per hour, CAT II and above \$2.50 per child per hour.

Patrons are responsible for paying for hours reserved, whether or not all time is used.

All full-day fees are due: **Monthly** - 1st of each month **Bi-Weekly** - 1st and 15th of each month.

Daily fees are based on 20 days per month.

MISCELLANEOUS FEES

Late Pick Up Fee \$1.00 per minute with a maximum of \$15.00 per family per CYS site.

a. Calculated in Hourly Care - \$5.00 per child for first 15 minutes past reserved pick up time, hourly rate per child thereafter.

Late Payment Fee

Late fee of \$10.00 for the first day and \$1.00 a day thereafter will be assessed on the 6th (monthly payment) or on the 6th and the 20th (bi-weekly payment) of each month.

Holding Fee Deposit

The fee to hold a child care space for a maximum of two weeks will not be refunded, but will be applied to the first two weeks of child care.

TDY Policy

Fees will not be reduced for parents on TDY.

Vacation Policy

Parents may request 2 weeks of vacation credit per registration year without loss of enrollment in the CDC.

Vacation credit must be taken in one week increments and **may not be** carried over to the next enrollment year.

Written advance notice (at least 1 day) is required before using vacation credit.

Sick Leave

Fees will not be reduced for absenteeism due to illness/injury.

Exception to Policy

Requests for exceptions to any stated fees or policies must be made in writing through the CDC Director for approval by the CYS Coordinator.
